## **2017 COMMONWEALTH SCHOLARSHIP IN THE UNITED KINGDOM**

**Last date for applying online in the Ministry: 16<sup>th</sup> September, 2016 (till 3:00 PM)**

Online application is invited from Indian national to apply for '**2017 COMMONWEALTH SCHOLARSHIP TENABLE IN THE UNITED KINGDOM**' for Master's & Doctoral degree programme. The study will commence in September/October 2017.

### **Number of nomination and award:**

Nomination: In total maximum 65 candidates would be nominated for this scholarship, which includes 26 nomination for PhD.

Award: The Commonwealth Scholarship Commission (CSC) would make the final selection from the nominated candidates. About 25 to 30 candidates would be finally awarded the scholarship.

- **Online applications:**

Candidates are required to apply online at **Ministry of Human Resource Development portal by 16.09.2016** (till 3:00 PM) and as well as at **Commonwealth Scholarship Commission's Electronic Application System (EAS) by 15.11.2016**. The important links are provided at the end of the public notice.

### **Notes:**

*It is mandatory for the applicant to apply on both the portals by the due date. The applicants who do not apply on both the portals would not be called for the interview.*

*Candidate can only apply either for Taught Master's course or PhD degree and only in one subject. More than one application would lead to disqualification.*
