Dr. Ram Manohar Lohiya National Law University, Lucknow was established by an Act of Govt. of Uttar Pradesh in 2005, U.P. Act No.28 of 2005 and came into being on 4th of January 2006 to meet up the new challenges in the legal field and to strengthen the vision that was given by the establishment of the first National Law School of the country. Originally incorporated as 'Dr. Ram Manohar Lohiya National Law Institute, Uttar Pradesh' word 'Institute' was substituted by the 'University' later, vide an amendment in the Act in November 2006. This was done to give a comprehensive national character to the Institute on lines with the other premier National Law Universities of the Country.

The University, which is getting liberal grants from the State Government, is committed to provide excellent infrastructural facilities and environment to advance and disseminate learning and knowledge of law and legal process and to develop in the students and research scholars a sense of responsibilities to serve the society in the field of law by developing skills in advocacy, judicial and other legal services and legislation and the like. Law has to deal with problems of diverse magnitudes and a student of law and an Advocate has to be trained in professional skills to meet the challenges of globalization and universalization of law. Objectives of the Conference

The coronavirus pandemic, which was first detected in China, has infected people in 188 countries. On March 11, 2020, the World Health Organization (WHO) characterized COVID-19 as a pandemic, pointing to over 3 million cases and 207,973 deaths in 213 countries and territories. The infection has not only become a public health crisis but has also affected the global economy. Significant economic impacts are now visible across the globe like reduced productivity, loss of life, business closures, trade disruption, and decimation of the tourism industry. The COVID-19 pandemic has had far-reaching economic consequences, far beyond the spread of the disease itself and the efforts to quarantine it.

As the SARS-CoV-2 virus has spread around the globe, concerns have shifted from supply-side manufacturing issues to decreased business in the services sector. This pandemic caused the largest global recession in history, with more than a third of the global population at the time being placed in lockdown. The COVID-19 pandemic is a global shock 'like no other', involving simultaneous disruptions to both supply and demand in an interconnected world economy. On the supply side, infections reduce labour supply and productivity, while lockdowns, business closures, and social distancing also cause supply disruptions. On the demand side, layoffs, and the loss of income (from morbidity, quarantines, and unemployment) and worsened economic prospects reduce household consumption and firms' investment. The extreme uncertainty about the path, duration, magnitude, and impact of the pandemic could pose a vicious cycle of dampening business and consumer confidence and tightening financial conditions, which could lead to job losses and investment. Key challenges for any empirical economic analysis of COVID-19 are how to identify this unprecedented shock, how to account for its non-linear effects, how to consider its cross-country spillovers (and other observed and unobserved global factors), and how to quantify the uncertainty surrounding forecasts, given its unprecedented nature. The COVID-19 pandemic is unprecedented in its global reach and impact, posing formidable challenges to policymakers and to the empirical analysis of its direct and indirect effects within the interconnected global economy.

With the above background, this conference will provide an ideal platform where the experiences and thoughts can be shared and assimilated to come up with a unified understanding of redefining pandemic impact on society and economy.

- d. Title Page –Title | Author(s) | Affiliation(s) | Contact Details | Key Words 4-5 Words
- e. Soft copy of the paper/article/essay/abstract (.doc/.docx format only) along with brief resume of the author and covering letter should be submitted via email to asedsconf@gmail.com
- f. Authors of accepted papers/articles/essay will be required to confirm their attendance by registration through Google form that will be circulated after the acceptance of the submissions made.
- g. Only few papers will be accepted for online presentation
- h. Editorial Board will follow the Anonymous Peer-Review policy, and reserves the right to reject or edit any paper whose content is offensive or defamatory, explicitly unethical etc.
