The female protagonist of the film Sonali Kulkarni who was expecting her marriage to be happening soon and she was trained for the marriage and living according to the wish of her husband was by mistaken kidnapped and finally raaped by three boys. A woman who is women from inside and outside of a body is brutally rape and finally she is rescued by Nirmal Pandey who was transgender and the brutal reality of the society exclude both of them.

### **MALE FEMALE RELATIONS**

One of the most Significant aspect of the film is male female relations beyond hetro sexual society.

Sonali Kulkarni has to save herself from the brutal and patriarchal world of men so she dressed up like a man and keep moustaches and behave like a man and then get a job in the Mechanic shop. Wwhen they are greeted by a family in which a widow mother she was expecting some sexual favour from Sonali Kulkarni who was dressed like a man and keeping artificial moustache on the face. This is so subtle and realistic that most of the people behave on the basis of outer appearance of human body and the performative action of the human body is expected from the male and female irrespective of their inner feelings.

Nirmal Pandey who is a male as his sexual identity but always dressed up like a female and having very long hair and keeping always is moustache and beard clean and doing lot of makeup on the face it was visible from the outside that she was a female but Sonali Kulkarni being the female was dressed up like a man and she was treated like a man.

Judith Butler when did she talks about the performative part of the human body what she is trying to say is that both the male and female body are being so different carry different tasks to perform for example a woman has two produce children and man has to behave according to a man. Gender performance which is assigned to man as said by Judith Butler. The question raised by Judith Butler is what about the non performing body which are biological e as a male and female but they are not able to a form according to their biological structure.
